

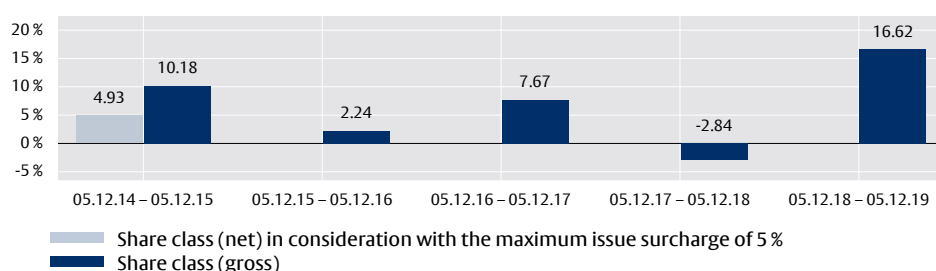

INVESTMENT STRATEGY

Flossbach von Storch - Dividend is a globally diversified equity fund with an active investment approach. It focuses on top-quality companies with an attractive dividend profile. Not only the dividend yield, but also the reliability of dividend and dividend upside potential are important. When selecting individual stocks, the fund management employs the CaRat (cash-flow rating) valuation model, a rating system developed in-house. The cash flows that the company is expected to generate on a sustainable basis are considered in relation to the total value of the company. This provides an indication of whether or not a company has an attractive stock market valuation. At least 75% of the fund's assets are invested directly in equities. In addition, the fund may also invest in share certificates, equity index certificates, as well as bonds, fixed-term deposits and target funds.

MONTHLY COMMENTARY

The US Federal Reserve (Fed) reduced its key interest rate for the third time in a row to a range of 1.5-1.75 per cent, but signalled it may pause before adjusting rates again. In December 2018, Fed Chairman Jerome Powell was still expecting three interest-rate increases this year. Mario Draghi's final Governing Council meeting at the European Central Bank (ECB) produced almost nothing newsworthy. Christine Lagarde, a lawyer and politician, has assumed the post of President and has already announced she will continue the use of expansive monetary policy. In our view, the low interest-rate level worldwide is a positive environment for equities. There is still no solution to the trade conflict between the USA and China. Global economic indicators are pointing to slower growth. Based on official data, Chinese growth is expected to be around six per cent this year, which would be the lowest rate in around 30 years. The US S&P 500 equity index recorded a new all-time high of 3,046 points in October. Gains were particularly large for cyclical equities, which also benefited the DAX index. The euro appreciated a good two per cent versus the US dollar during this period. This reduced performance from the point of view of euro investors. Philip Morris, Fuchs Petrolub and HDFC Bank provided the largest positive contributions to value over the month, while British American Tobacco, IBM and McDonald's made the largest negative contributions.
